<sup>2</sup>) If case processing is required, an hourly rate or part thereof will be charged.

<sup>3</sup>) NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

<sup>4</sup>) No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

<sup>5</sup>) Where several documents are issued together to the citizen, a total fee of DKK 200 shall be charged.

<sup>6</sup>) Provided the request for VAT refund comprises several separate purchases, a fee of DKK 200 shall be charged per statement.

<sup>7</sup>) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,265 shall be charged for the first passport and DKK 970 for subsequent passports.

<sup>8</sup>) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,240 shall be charged for the first passport and DKK 970 for subsequent passports.
