<sup>5)</sup> Where several documents are issued together to the citizen, a total fee of PLN 116 shall be charged.

- <sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of PLN 116 shall be charged per statement.
- <sup>7)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of PLN 1370 shall be charged for the first passport and PLN 588 for subsequent passports.
- <sup>8)</sup> Where several provisional passports or extension of passports are issued at the same time, a fee of PLN 1957 shall be charged for the first passport and PLN 588 for subsequent passports.
