³⁾ NB: A fee of EUR 35 (DKK 260) (149 PLN) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

⁴⁾ Where several documents are issued together to the citizen, a total fee of DKK 285 (164 PLN) shall be charged.

⁵⁾ Provided the request for VAT refund comprises several separate purchases, a fee of DKK 230 (132 PLN) shall be charged per statement.

⁶⁾ Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,675 (1538 PLN) shall be charged for the first passport and DKK 1,145 (658 PLN) or DKK 1,786 (1027 PLN) for subsequent passports.

- 7) Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,820 shall be charged for the first passport and DKK 1,145 or DKK 1,786 for subsequent passports.
- 8) The fee may increase to 135 or 180 if an implementation decision has been adopted in the EU in accordance with the Visa Code Article 25a. Does not apply to children up to and including eleven years of age.
