<sup>3)</sup> NB: A fee of EUR 35 (DKK 260) shall be charged for countries with which the European Commission has concluded or is negotiating a visa facilitation agreement.

<sup>4)</sup> No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents – or one of these – were born Danish or have subsequently obtained Danish nationality.

<sup>5)</sup> Where several documents are issued together to the citizen, a total fee of DKK 200 (PLN 121) shall be charged.

<sup>6)</sup> Provided the request for VAT refund comprises several separate purchases, a fee of DKK 200 shall be charged per statement.

<sup>7)</sup> Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 2,265 (PLN 1370) shall be charged for the first passport and DKK 995 (PLN 587) for subsequent passports.

<sup>8)</sup> Where several provisional passports or extensions of passports are issued at the same time, a fee of DKK 3,240 (PLN 1959) shall be charged for the first passport and DKK 995 (PLN 622) for subsequent passports.
